WHEREAS, recognition was granted to the institution namely Sri Venkata Ramana College of Education, D.No.6-29, Bhimareddy Nagar, Ravulapalem, East Godavari District-533338, Andhra Pradesh run by Sri Venkata Ramana Educational Society, Tanuka, Andhra Pradesh vide SRC (NCTE) order no. F.SRO/NCTE/B.Ed/2006-2007/2396 dt. 09.05.2007 for conducting B.Ed. course of one-year duration with an annual intake of 100 (Two units) students from the academic session 2006-2007.

- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution is submitted affidavit dt 23.01.2015 for its willingness for adherence of provisions of new Regulations.
- AND WHEREAS, a Revised Provisional Recognition Order was issued to the institution on 19.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16 with condition to that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 09.05.2007. The institution has not submitted reply till date.
- AND WHEREAS, the SRC in its 294th meeting held on 14th 16th November, 2015 4. considered the list of colleges not submitted documents for shifting in compliance to the condition laid down in revised recognition order for 2015-16 and it has decided to issue show cause notice for withdrawal of recognition under NCTE act for the following deficiencies;
 - The institution has not submitted documents for shifting as mentioned in the revised recognition order as per the regulation, 2014.
- AND WHEREAS, the SRC in its 369th meeting held on 28.01.2019 considered the matter and decided that Show Cause Notice be issued to all such institutions which have not submitted compliance of conditions stipulated in RPRO. The institution submitted written representation on 25.03.2019 & 04.04.2019. The SRC in its 376^{th} meeting held on $11^{th}-12^{th}$ June, 2019 considered the matter and decided as under:

The Committee decided that Visiting Team be constituted to verify the infrastructural and instructional facilities available with the institution. The VT shall also verify the facilities for existing recognized teacher education courses and ascertain the fulfillment and maintenance of regulations and norms and standards for the existing courses as well being run by the same Society.

- 6. AND WHEREAS, as per the decision of SRC a letter was sent to the institution on 17.06.2019. The institution vide letter dated 26.06.2019 submitted its reply to the letter. The SRC in its 379th meeting held on 21st 22nd August, 2019 considered the matter and decided to issue a SCN. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on 29.08.2019. The institution vide letter dated 13.09.2019 submitted reply to the Show Cause Notice.
- 7. **AND WHEREAS**, the SRC in its 380^{th} meeting held on $18^{th}-19^{th}$ September 2019 considered the matter and decided to issue a SCN. Accordingly as per the decision of SRC a show cause notice was issued to the institution on 25.09.2019. The institution vide letter dated 23.10.2019 submitted reply to the Show Cause Notice. The SRC in its 382^{nd} meeting held on $26^{th}-27^{th}$ November, 2019 considered the matter and decided as under:

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee decided to permit the institution to shift its premises at a new premise and a continuation order be issued to Sri Venkataramana College of Education, D.No.6-29, Bhimareddy Nagar, Ravulapalem, East Godavari District-533338, Andhra Pradesh for B.Ed programme for 2 units (50 students each unit).

- 8. NOW THEREFORE, this order is issued permitting the institution i.e. Sri Venkata Ramana College of Education, D.No.6-29, Bhimareddy Nagar, Ravulapalem, East Godavari District-533338, Andhra Pradesh to shift its premises at new address at Survey No. 206/1, Gangavaram Village, Gurazala Mandal, Guntur District-522415, Andhra Pradesh run by Sri Venkata Ramana Educational Society, Tanuka, West Godavari District, Andhra Pradesh and continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units) of 50 each subject to fulfillment of the following conditions:
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
 - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc as applicable.
- 10. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students:
 - f. Available infrastructural facilities;
 - Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 13. The institution shall make available the list of students admitted on its official website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawa! of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.
